#### **CALL TO ORDER:**

**1) Introductions**

The new Communications Coordinator Kelsey Janzen was introduced.

Justin Ellis, Specialist – Process Excellence was introduced.

#### **DELEGATIONS:**

**1) RCMP – Sgt. Mike Numan**

Sgt. Mike Numan presented to Council the RCMP Quarterly Update.

**2) MP Thomas**

MP Rachel Thomas was present to connect with Council and to understand Council's priorities and how best to advocate for them.

**3) Picture Butte Rural Crime Watch – Lyle Adams**

Lyle Adams from the Picture Butte Rural Crime Watch was present to advise Council that the Picture Butte Rural Crime Watch will be dissolving due to lack of uptake in memberships and information from the community.

#### **SUBDIVISION APPLICATIONS**

**1) Subdivision Application #2024-0-008 – Coles – Lot 1, Block 1, Plan 9510246 within SE ¼ 32-9-20-W4**

Council approved the subdivision application subject to the conditions outlined in the draft resolution. The application is to reconfigure an existing 3.00 acre title and reduce it in size to 2.00 acres for country residential use.

**2) Subdivision Application #2024-0-007 – Slingerland/Stoutjesdy – Lots 1 & 2, Block 1, Plan 1113094 within NE ¼ 27-10-23-W4**

Council approved the subdivision application subject to the conditions outlined in the draft resolution. The application is to reconfigure property boundaries and size of two adjacent titled properties, 3.13 and 2.25 acres in size, by subdividing and consolidating 0.3 acres to the create titles 2.83 and 2.55 acres in size for country residential use.

**3) Subdivision Application #2024-0-010 – Johnson – SE ¼ 20-11-21-W4**

Council approved the subdivision application subject to the conditions outlined in the draft resolution. The application is to subdivide a 2.51 acre first parcel out subdivision from a ¼ section title of 147.20 acres for country residential use.

**4) Subdivision Application #2024-0-017 – Steperski – NE ¼ 34-13-20-W4**

Council approved the subdivision application subject to the conditions outlined in the draft resolution. The application is to subdivide a 6.17 acre first parcel out subdivision from a ¼ section title of 157.83 acres for country residential use.
