

# Council Brief of the September 7, 2023 Regular Meeting This document is provided for informational purposes only and is not the approved minutes of the Lethbridge County Council meeting.

## **DELEGATIONS:**

- 1) RCMP Quareterly Update RCMP Sgt. Dave Marentette and Cst. Joel Leclerc presented Council with an update on activities.
- 2) Iron Springs Water Co-op Members from the Iron Springs Water Co-op were present for a discussion with Council.

#### **SUBDIVISION APPLICATIONS**

1) Application #2023-0-076 – Atkinson - SW1/4 11-11-23-W4M

Council approved the supplication subject to the conditions outlined in the draft resolution. The application is to subdivide a 50.37-acre first subdivision from a title of 159.48 acres for agricultural use.

2) Subdivision Application #2023-0-089 – Schalk - Lots 1-8, Plan 8986EC, ptn. of NE1/4 21-09-22-W4M

Council approved the supplication subject to the conditions outlined in the draft resolution. The application is to reconfigure the property boundaries (property line adjustment) and size of five adjacent titled properties, by subdividing and consolidating to create three new titles for country residential use.

3) Subdivision Application #2023-0-098 – 1553201 Alberta Ltd./Neels - Part of NW1/4 21-9-22-W4M Council approved the supplication subject to the conditions outlined in the draft resolution. The application is for a property boundary realignment of two adjacent parcels by subdividing a 0.99-acre strip of land for an access from a title of 35 acres and consolidate it to an adjacent title for country residential use.

- a. Bylaw 23-020- Development Authority Bylaw Council approved first, second, and third readings of the bylaw, which was updated to reflect current practice around the Development Authority roles.
- b. Bridge File 79589 Request for Budget Increase

Council approved the request for an additional \$137,000 from the Bridges and Paved Roads Reserve, for a total project cost of \$437,000. During the design phase of the project, it was identified that the bridge will need to be built to accommodate higher flows than was identified in the budget estimate. The additional funding will also increase the estimated lifecycle of the bridge from 50 years to 75.
