

Council Brief of the March 16, 2023 Regular Meeting This document is provided for informational purposes only and is not the approved minutes of the Lethbridge County Council meeting.

PUBLIC HEARINGS:

1) Bylaw 22-021 - Road Closure, Sale and Consolidation

Council approved that the bylaw be sent to the Minister of Transportation for approval and that land fees be waived. The application is to close a portion of Road Plan 9511762 (Township Road 9-0B) to be consolidated with the adjacent lot to the north. If the bylaw receives Ministerial approval, second and third reading can proceed.

DEPARTMENT REPORTS:

1) COMMUNITY SERVICES

a. Bylaw 23-002 - Country Crossroads Estate Area Structure Plan and Bylaw 23-003 Land Use Bylaw Amendment (Rural Agriculture to Grouped Country Residential) - First Reading Council approved first readings of both bylaws, which would allow for the phased subdivision of the parcels for Country Residential use in the SW5-8-20-W4. A public hearing is anticipated for April 2023.

2) CORPORATE SERVICES

a. 2023 Post-Secondary Bursary and Bursary Ad-Hoc Selection Committee

Council approved that the 2023 post-secondary bursary program increase the number of awards from 2 to 3 and the amount be increased from \$1,000 to \$1,500, with the additional funding to come from the Council Discretionary Reserve. Deputy Reeve John Kuerbis and Councillors Lorne Hickey and Mark Sayers were chosen to sit on the Ad-Hoc Bursary Selection Committee. b. 2022 Year End Surplus/Deficit Report

Council received the report, which showed an overall unaudited operating deficit of \$395,000. Council approved that the reallocation of funds from Restricted Surplus (Reserves) to Unrestricted Surplus be transferred from the Tax Equalization Reserve in the amount of \$395,000 to offset the 2022 deficit.

c. 2023 Business Tax Bylaw 23-010

Council approved first, second, and third readings of the bylaw, which allows for the collection of a Business Tax for 2023.

d. 2023 Business Tax Rate Bylaw 23-011

Council approved first and second readings of the bylaw.

3) MUNICIPAL SERVICES

a. Road Ban Information

Council received information from administration on the current Road Ban Bylaw and Road Ban Policy. These are in place to protect the County's roads from damage from overweight commercial vehicles when the roads are most susceptible to damage.

b. 2023 Public Works Level of Service Policy

Council approved the 2023 Public Works Level of Service Policy, which provides an overview of road maintenance activities in hamlets, subdivisions, and rural areas. The full document is available at https://whatshappening.lethcounty.ca/level-of-service.

1) Minister of Transportation – Highway 25 Conversion

A letter was received from the Alberta Minister of Transportation informing the County that a 19.4-kilometre portion of Highway 25 from Highway 521 to Highway 526 will be converted to gravel.

2) Minister of Municipal Affairs

A letter was received from Alberta Municipal Affairs introducing municipalities to the Local Government Fiscal Framework that will provide infrastructure funding. Additionally, the Municipal Sustainability Initiative funding will be increased for municipal operations and the federal Canada Community Building Fund will also be available.

A letter was received from MP Rachel Thomas requesting a meeting with Council to discuss current challenges and opportunities in the County.

4) Fortis Alberta Invitation

An invitation for Council was received from FortisAlberta to the grand opening of their flagship Net-Zero building in Coaldale on April 20.
