

Council Brief of the November 17, 2022 Regular Meeting

DELEGATIONS:

1) Guided Journeys Foundation

Celeste Ment provided an overview of the foundation, which provides hospice and palliative care. Council was invited to their upcoming Frost and Flare Gala on November 26, 2022 at the Norland Historic Estate. Council approved that any member wishing to attend be authorized to do so.

DEPARTMENT REPORTS:

1) COMMUNITY SERVICES

a. Community Peace Officer Report (July – September 2022)

The Community Peace Officer provided an update on activities from July to September:

- 62 case reports created (compared to 98 in 2021)
- Notable decrease to unsightly premises and Fire Bylaw-related complaints; slight increase in Dog Control Bylaw complaints
- Majority of Highway Protection Bylaw reports were for pivot end guns watering roads
- Joint force operations included the Lethbridge Air Show, Commercial Vehicle Inspections, August long weekend check stop, and traffic control at motor vehicle collisions

b. Animal Control Bylaw Review - Council Options

Council directed administration to amend the current Animal Control Bylaw to allow for the keeping of animals in hamlets based on parcel size, but to limit to a maximum of five animal units. The amended bylaw will be brought forward for consideration of first reading at the December 15 Council meeting.

c. Fire Services Response Fees Waiver Request

Council directed administration to bring a report to the December 1 Council meeting containing cost estimates for the fire response in question.

2) ADMINISTRATION

a. Foothills Little Bow Municipal Association Resolution

Council directed administration to bring forward a draft resolution to a future Council meeting that would be put forth at the Foothills Little Bow Municipal Association Meeting in January.
