

Council Brief of the March 2, 2023 Regular Meeting

DELEGATIONS:

1) RCMP Quarterly Report

S/Sgt. Mike Numan and Sgt. Dave Marentette of the Coaldale RCMP detachment provided Council with an update on recent activities and crime statistics. These are available on our website at https://www.lethcounty.ca/p/emergency-services under the "Policing - RCMP" tab.

2) Cor Van Raay LINK Pathway Council Resolution Review - Phase 2

Council received a presentation from the Cor Van Raay LINK Pathway Committee on the proposed Phase 2 segment of the project. Phase 2 of the LINK Pathway and corresponding Memorandum of Understanding between Lethbridge County, the Saint Mary River Irrigation District and the LINK Pathway Committee was approved.

PUBLIC HEARINGS:

1) Bylaw 23-005 - Lethbridge County and Town of Coaldale Intermunicipal Development Plan - Public Hearing

Council approved second and third readings of the bylaw, which provides a framework to address land use and development in the fringe area between Lethbridge County and the Town.

DEPARTMENT REPORTS:

1) MUNICIPAL SERVICES

a. Bylaw 22-018 - Speed Limit Bylaw

Council approved the amended bylaw, which designates speeds on County roadways. Under the bylaw, all hamlets and subdivisions are 40km/hr (with the exception of Shaughnessy, Vista Meadows, and McKechney Ave in Diamond City remaining at 30 km/hr), industrial parks are 50 km/hr, and Township Road 9-2 starting from Highway 512 to the east is established at 60 km/hr, then 30 km/hr nearing the Stafford Lake campground. 2) ADMINISTRATION

a. Canadian Fallen Heroes Foundation - Donation Request

Council approved a \$500 donation to the Foundation to recognize and honour many of the Lethbridge County veterans who have served Canada. Funds will be utilized from the Councillors Discretionary Reserve.

b. Request for Sponsorship - Alberta / NWT Command - Royal Canadian Legion - Annual Military Service Recognition Book

Council approved a \$625 advertisement in the publications to support and acknowledge those brave individuals who sacrificed for freedom in Canada. Funds will be utilized from the Councillors Discretionary Reserve. Council also directed administration to bring a report to a future meeting with the County's donation history over the past 5 years.

c. Truth and Reconciliation Advisory Committee Bylaw #23-007

Council approved that a committee be established to work toward bringing a potential Indigenous land acknowledgement to a future meeting for consideration. Councillors Mark Sayers, Lorne Hickey, and Klaas Vander Veen were appointed to the committee.

3) COMMUNITY SERVICES

a. Animal Control Bylaw 22-020
