G.3. <u>Del Strazza Re: County Billing Issues</u>

Reeve Hickey welcomed Mr. Del Strazza to the meeting at 11:08 a.m. Council introduced themselves to Mr. Strazza.

Mr. Strazza discussed the following with Council:

- There was a matter of an amount being assessed to him and added to his tax notice dating back to 2012. He has tried to resolve this, but the matter seems to be completely shrouded in mystery with conflicting answers as for the origin of this charge.
- There was a charge for a response to a fire call to his property in 2018, this response resulted in damage to his property equal to or in excess of the billed amount.
- Another response to a fire call in April of this year was the final charge outstanding.
- A final matter that the County has assessed and taxed his property for more land than what was actually there, payment has been made yearly for taxes on land he did not own for some 29 years.

Reeve Hickey welcomed Mr. Allan Friesen from the SAFE Society / Lethbridge Fish and Game Association to the meeting at 1:30 p.m. Council introduced themselves to the delegation.

Mr. Friesen gave a presentation regarding the following:

- Messaging and awareness on how far projectiles can travel.
- Public awareness on firearm safety, responsibility and life.
- Youth use the range for free.
- Association has a lease with City of Lethbridge till 2036 for the location at Peenaquim Park, near Softball Valley. At that time the Association will discuss where to relocate to; location yet to be determined but possibly Lethbridge County. Could relocate prior to 2036 if an ideal location can be found.
- Enhancing current facility to a 'Total Containment Range' which is portable and can be relocated to new location.
- Thanks to the County for assisting in getting the messaging of gun safety out to the public.

- There are 1700 members and the facility is run by 30 volunteers.
- Lethbridge County pursuing discussions with the 2020 Alberta Summer Games.
